

RECALL TRIAL VERSION SOFTWARE EVALUATION LICENSE AGREEMENT

A1. The Software Product

- A1.1 The subject of this Evaluation Licence is the RECALL Trail Version ("RECALL-TV") software product in which this Evaluation Licence is embedded and any related updates provided to the Licensee, including computer software and, where applicable, associated media, printed materials and online or electronic documentation ("Software Product").
- A1.2 Thank you for licensing the use of the accompanying software product. It is important that you, the Licensee, read these terms carefully. These are the only terms and conditions applicable to your use of the Software Product. The Software Product is protected by copyright laws and international copyright treaties, as well as other intellectual property laws. All rights not expressly granted to you in this license agreement are reserved to Think Research Limited. The Software Product is licensed, not sold.

A2. Evaluation Licence Grant

- A2.1 Think Research has provided the Licensee with a copy of the Software Product for evaluation purposes subject to the terms and conditions of this Evaluation Agreement. This non-exclusive, non-transferable Evaluation Licence allows the Licensee to use the Software Product solely on the laptop supplied by Think Research to the Licensee for the purposes of evaluating the Software Product for an agreed period from the date of the accompanying Agreement signed between Think Research and the Licensee.
- A2.2 This evaluation Licence permits the Licensee to use the Software Product strictly in a research environment for the sole purpose of evaluating the suitability of the Software Product to the Licensee's internal, end-use purposes (excluding the commercialisation of information technology products and/or services).
- A2.3 This evaluation licence does not permit the Licensee to make any copies of the Software Product for any purpose whatsoever. The Software Product is provided "as is" without any warranty or condition of any kind, either express or implied, during the evaluation period.

A3. Licence Restrictions

- A3.1 The Software Product which is the subject of this Evaluation Agreement is licensed to the Licensee, not sold.
- A3.2 The Licensee may not use or copy the Software Product, in whole or in part, except as expressly provided for in this licence.
- A3.3 The Licensee may not modify, translate, reverse engineer, decompile, disassemble or create derivative works of the Software Product or otherwise attempt to (a) defeat, avoid, by-pass, remove, deactivate or otherwise circumvent any software protection mechanisms in the Software Product including, without limitation, any such mechanism used to restrict or control the functionality of the Software Product or (b) derive the source code or the underlying ideas, algorithms, structure or organization form of the Software Product.
- A3.4 The Licensee may not assign, rent, transfer, sell, disclose, deal in, make available or grant any rights in the Software Product in any form to any person.

- A3.5 The Licensee may not remove alter, obscure, interfere with or add to any proprietary notices, labels, trade marks, names or marks on, annexed to, or contained within the Software Product.
- A3.6 The Licensee may not use the Software Product in any manner that infringes the intellectual property or other rights of Think Research or any other party.
- A3.7 The Licensee may not use the Software Product in any commercial venture in competition to Think Research.
- A3.8 The Licensee will at all times, including during and after the term of this Evaluation Licence, keep the software product confidential.
- A3.9 The Licensee shall comply with all applicable export laws and regulations.

A4. Intellectual Property Rights

- A4.1 The Intellectual Property Rights embodied in the Software Product, to include, but not be limited to, the concepts, ideas, information, data, drawings, reports, documentation, works of authorship, trade secrets, techniques, know-how, ideas, concepts, algorithms, and other intellectual property incorporated in the Software Product shall remain the ownership of Think Research.

A5. Ownership

- A5.1 The Software Product is protected by copyright and is proprietary and confidential to Think Research. All right, title and interest in and to the Software Product (including associated intellectual property rights) are and will remain vested in Think Research. These rights are protected by national and other laws and international treaties. The Licensee acknowledges that no rights, licence or interest to any Think Research trademarks are granted hereunder.

A6. Term of Licence

- A6.1 This Evaluation Licence shall be in effect from the time the Licensee signs this Evaluation Agreement, thereby accepting the terms and conditions contained herein, or otherwise expressly accepts the terms and conditions of this Licence, and shall remain in effect until the agreed period has elapsed. This Evaluation Licence will otherwise terminate upon the conditions set forth in this Evaluation Agreement or if the Licensee fails to comply with any term or condition of this Evaluation Agreement including failure to pay any applicable Licence fee. The Licensee agrees upon termination of this Agreement for any reason to immediately return the Laptop and all elements of the Software Product in its possession and/or under its control.

A7. Limitation of Liability

- A7.1 The Software Product is provided "as is" without any warranty or condition of any kind, either express or implied. Without limitation, to the fullest extent allowable by law, this exclusion of all other warranties or conditions extends to implied warranties or conditions of merchantable quality and fitness for a particular purpose and those arising by statute or otherwise in law or from a course of dealing or usage of trade.
- A7.2 Notwithstanding anything to the contrary contained herein, in no event shall Think Research be liable under any theory of contract, tort, strict liability or other legal or equitable theory

for any indirect, consequential, special or incidental damages, even if Think Research has been advised of the possibility thereof including, without limitation, lost profits, lost business revenue, other economic loss or any loss of recorded data arising out of the use of or inability to use the Software Product or the cost of procuring substitute products or services.

A8. General Provisions

- A8.1 The limitations of liability and ownership rights of Think Research contained herein and the Licensee's obligations following termination of this Evaluation Agreement shall survive the termination of this Evaluation Agreement for any reason.
- A8.2 The Licensee may not sublicense, assign, share, pledge, rent or transfer any of its rights under this Evaluation Agreement in relation to the Software Product or any portion thereof including documentation.
- A8.3 No amendments or modifications may be made to this Evaluation Agreement except in writing signed by both parties.
- A8.4 If one or more provisions of this Evaluation Agreement are found to be invalid or unenforceable, this Evaluation Agreement shall not be rendered inoperative but the remaining provisions shall continue in full force and effect.
- A8.5 This Evaluation Agreement constitutes the entire agreement between the parties with respect to the subject matter of this Evaluation Agreement and merges all prior communications except that a "hard-copy" form of licensing agreement relating to the Software Product previously agreed to in writing by Think Research and the Licensee shall supersede and govern in the event of any conflicting provisions.
- A8.6 This Evaluation Agreement shall be governed by the laws of England and Wales.
- A8.7 The parties (so far as is lawful) expressly disclaim the application of the United Nations Convention on Contracts for the International Sale of Goods and (as previously stated) all statutory imposed or implied terms of warranty or condition as to fitness for purpose and quality are excluded but provided further that where (as is the case in countries comprising the European Free Trade Area) it is not possible in all circumstances to exclude such obligations warranties or conditions (for example where personal injury or death results) then such implied terms are incorporated herein but not further or otherwise and the terms of this licence shall be construed accordingly. Further for the purpose of sales within the United States of America or where the following regulations have application there is excluded from this licence any state Uniform Computer Information Transactions Act or similar federal, provincial or state laws or regulations.
